Action Taken: On 2/22/07 at 13:30 hours, I learned from Steve Tillery at Patton Middle School that he'd received a report from a teacher of inappropriate hallway activities. According to Mr. Tillery, two boys, Ryan Cornelison and Cory Mashburn were seen by a staff member spanking on her buttocks. The teacher issued the boys a referral and sent them to see Mr. Tillery. He had already spoken to the boys and they both admitted they'd spanked on the buttocks.
At 13:38 hours, I interviewed to take the boys did spank her buttocks today, but that this activity had been going on for several weeks. She stated that today, Ryan told her it was, "Slap butt day," then proceeded to spank her along with Cory's help. She said the slap Ryan gave her was particularly painful. She rated her pain as a 7 on a pain scale of 1-10 (10 being the worst). This took place today during her lunch break between 12:53-13:22 hours.
Ryan has even grabbed her breast in the hallway about two weeks ago. She told me that he, "Scooped," her breast, grabbing it under the breast, cupping it with his hand, then lifting it. She stated whenever she tells Ryan not to touch her, he says it's, "An accident." was very rejuctant to tell-me about the scooping-incident and stated she was embarrassed. She had great difficulty describing the incident and would only refer to her breast by calling it her, "Chest," and pointing to her left breast.
estimates that Ryan has either grabbed or slapped her buttocks at least 20 times. She said he grabbed her breast 1 time. She told me this makes her feel, "Uncomfortable," and she stated she's told him not to touch her repeatedly. Said that Cory has also touched her buttocks on more than 1 occasion, but has never touched her breast. She was unable to say how many times other than today that Cory had touched her.
At 13:47 hours, I met with the property of the continuence of the cont
According to Cory has touched her buttocks, "Around 10 times," over the past 2 weeks. She said most of the touching has been to her, "Rear." He has attempted to touch her stomach, but she has always pushed his hand away. He last touched her buttocks today during her lunch break when he touched her twice. Cory has, "Scooped," her breast on one occasion as well, although she could not remember when it happened in the past 2 weeks. She stated the contact makes her feel uncomfortable because she doesn't like being touched in her private areas.
At 13:55 hours, I interviewed that both Ryan and Cory, "Smack me on the butt." She did not have any specifics as to how many times each boy has touched

her but, she said that Cory specifically had done it, "2-3 times today." I added that she'd told him to stop, but he

At 14:00 hours, I spoke with a 12-year-old student at Patton in Mr. Tillery's office. Said that both Cory and Ryan, "Swatted my rear today, 1 time each." She said that it hurt her buttocks and she described the pain as a 3 on a scale of 1-10 (10 being the worst). She said having her buttocks touched made her, "A little uncomfortable." She said this has happened to her before from Cory when they are hanging out outside of school. She has told both boys to stop touching her but they will not stop.

Said Ryan and Cory will get on either side of her and trap her between them, then rub themselves against her. Said both boys have slapped and grabbed her buttocks in the past, although she does not remember when. She did state that several other students have grabbed her in the past as well.

At 14:55 hours, I interviewed Ryan Cornelison in Mr. Tillery's office. I immediately advised him of his Miranda Rights from my department issued card. Ryan stated he understood his rights by saying, "Yes." Before I ever asked Ryan a question, he volunteered the statement, "Yes, I slapped them on their butts." Ryan stated that he'd slapped every girl he'd seen me interview on the butts, but said he never meant to hurt them. He told me he'd been touching them for about 1 week because he was, "Just messing around." He said the girls were all his friends and he thought touching them was funny. Ryan said that although the girls never told him to stop, he knew they did not like it because they would always get mad about it. He does not know how may times or how many girls he's touched. Ryan told me he never touched breast, but he did admit to scooping a girl named breast a while back. He also told me he has no idea how may girls he and Cory have dry humped against, but he acknowledges doing so to all the girls mentioned above. Ryan also told me he knows the girls don't like it when he does this.

At 15:03 hours, I interviewed Cory Mashburn in Mr. Tillery's office. I immediately advised him of his Miranda Rights from my department issued card. Cory stated he understood his rights by saying, "Yeah." I asked Cory if he know why I'd interviewed all the girls he saw coming into the office today and he told me, "Those girls are here because we smacked their butts." He told me that although he had smacked the girls, he thought that and were o.k. with it because they have also smacked his butt. He said the whole thing was, "Nothing big." He admitted he, "Might," have smacked every girl I interviewed. Cory said he often will dry hump the girls with Ryan, but said he's never scooped the girls. He did admit, however, to poking numerous girls in their, "Boobs," with his finger. He was not sure who he'd poked. Cory said he knew the girls did not like being touched because they would hit him after he smacked their butts.

Mr. Tillery agreed to notify all of the victim's parents on my behalf. I arrested Cory and Ryan and transported them to the Juvenile Detention Facility per PO Lynch's request. Both boy's were charged with Sex Abuse I. After they were booked, I returned to Patton and met with Ryan's father and Cory's mother and father in person.
